NOTICE IS HEREBY GIVEN that HENRY KYSAR LOGGING, INC. of Clark County, State of Washington, claims a lien upon Douglas Fir and Hemlock logs, being about 696,000 board feet in quantity, which were cut in Section 2, Township 6 North, Range 6 East of the Willamette Meridian, in Skamania County, State of Washington, and are marked "BN 26", and are now lying in rafts situate principally in Cowlitz County, State of Washington, and are also situate in Pacific Lumber & Shipping Company's yard in Longview, Washington and in the Columbia River/Columbia River slough near Longview, Washington, in Rain Creek Log Sorting Company's Cheatchie yard and in Vanport Manufacturing Company, Inc.'s yard in Porine, Oregon, for labor performed upon and assistance rendered in loading said logs and providing a 266 Pantam hydraulic loader; that the name of the owners or reputed owners are PURLINGTON NORTHERN, INC., PACIFIC LUMBER & SHIPPING COMPANY, RAIN CREEK LOG SORTING COMPANY, and VANPORT MANUFACTURING COMPANY, INC.; that MY SON'S LOGGING, INC. employed said HENRY KYSAR LOGGING, INC. to perform such labor and render such assistance upon the following terms and conditions, to-wit:

That said MY SON'S LOGGING, INC. agreed to pay the said HENRY KYSAR LOGGING, INC. Fifty and no/100ths (\$50.00) Dollars per hour plus mileage and costs of long distance telephone calls, for such labor and assistance and equipment; that said contract has been faithfully performed and fully complied with on the part of said HENRY KYSAR

LOGGING, INC., who performed labor upon and assisted in loading said logs for a period including June and July, 1982, that said labor and assistance were so performed and rendered upon said logs including the time between the 1st day of June and the 16th day of July, 1982; and the rendering of said service was closed on the 16th day of July, 1982, and 30 days have not elapsed since that time; that the amount of claimant's demand for said service is Sixteen Thousand and 31/100ths (\$16,000.31) Dollars; that no part thereof has been paid except Six Thousand Eight-Nine and 31/100ths (\$6,089.31) Dollars, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of Nine Thousand Nine Hundred Eleven (\$9,911.00) Dollars, in which amount he claims a lien upon said logs.

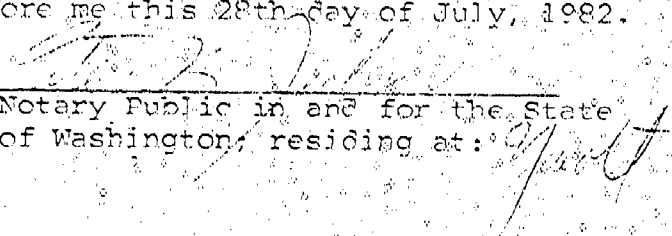
