AMENDED LIEN

W.N. BUCHANAN, CLAIMANT, VS. BURLINGTON NORTHERN RAILROAD AND

NOTICE IS HEREBY GIVEN that W.N. Buchanan of Cowlitz County,
State of Washington, claims a lien upon logs, being about 28 loads
in quantity, which were cut or manufactured in Skamania County,

lying in the following places:

approximately 80,000 feet.
- B. Wall Boom, Woodland, Cowlitz Co., Washington approximately
25,000 feet.
- C. Van Port Manufacturing, Boring, Clackamas Co., Oregon
approximately 30,000 feet.
- D. Rain Creek Sorting Yard, Chelatchie Prairie, Clark Co.,
Washington approximately 5,000 feet.

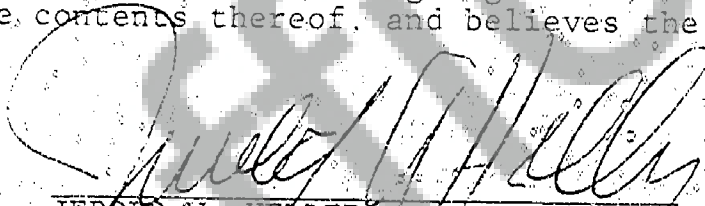
for labor performed upon and assistance rendered in hauling said
logs; that the name of the owner or reputed owner is Burlington
Northern Railroad (B/N) whose agent is My Son's Logging, Inc., that
B/N and My Son's Logging, Inc., employed said W.N. Buchanan
to perform such labor and render such assistance upon the following
terms and conditions, to wit:

The said B/N and My Son's Logging, Inc., agreed to pay the
said W.N. Buchanan for such labor and assistance \$5858.57; that
said contract has been faithfully performed and fully complied
with on the part of said W.N. Buchanan who performed labor upon
and assisted in hauling said logs for the period of two months;
that said labor and assistance were so performed and rendered upon
said logs between the 11th day of May, 1982, and the 12th day of July,
1982; and the rendition of said service was closed on the 12th day of
July, 1982; and thirty days have not elapsed since that time; that
the amount of claimant's demand for said service is \$5858.57;
that no part thereof has been paid except \$3,057.00; and there is
now due and remaining unpaid thereon, after deducting all just
credits and offsets, the sum of \$2,801.57 in which he claims a

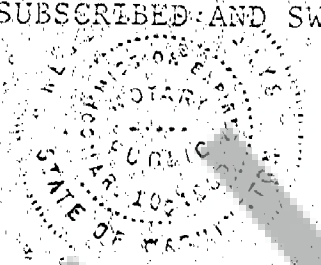
lien upon said logs. The said W.N. Buchanan also claims a lien on all said logs now owned by said B/N and My Son's Logging, Inc., of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
