DESCRIPTION

LOT 3, OF SKAMANIA LIGHT AND POWER COMPANY'S ELECTRIC ADDITION ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE AND OF RECORD IN THE OFFICE OF THE AUDITOR OF SKAMANIA COUNTY, WASHINGTON.

EXCEPT THE FOLLOWING DESCRIBED PORTION THEREOF:

BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 3; THENCE WEST ALONG THE NORTH LINE OF THE SAID LOT 3 A DISTANCE OF 165 FEET TO THE INITIAL POINT OF THE TRACT HEREBY EXCEPTED; THENCE SOUTH 50 WEST TO THE INTERSECTION WITH THE EAST-ERLY LINE OF THE EXISTING COUNTY ROAD KNOWN AND DESIGNATED AS FARM TO MARKET ROAD; THENCE FOLLOWING THE EASTERLY LINE OF SAID COUNTY ROAD 250 FEET, MORE OR LESS, TO INTERSECTION WITH THE NORTH LINE OF THE SAID LOT 3; THENCE EAST ALONG THE NORTH LINE OF THE SAID LOT 3 A DISTANCE OF 200 FEET, MORE OR LESS, TO THE INITIAL POINT, TOGETHER WITH AN EASEMENT FOR AN ACCESS ROAD TO SAID PROPERTY OVER AND ACROSS THE PRIVATE ROAD AS NOW CONSTRUCTED AND LOCATED UPON THE EXCEPTED TRACT DESCRIBED ABOVE.
