

15 Whereas, in the above-entitled court on the 12th day of  
16 August, 1982, plaintiff herein secured a Judgment against the  
17 defendant Betty E. Jones for the sum of TEN THOUSAND TWO HUNDRED  
18 FORTY-EIGHT DOLLARS AND FORTY-SIX CENTS (\$10,248.46) which includes  
19 interest in the amount of \$822.98, together with \$100.76 as late  
20 charges, together with plaintiff's reasonable attorney fees in  
21 the sum of \$2,000.00, together with costs of title search in  
22 the amount of \$105.00, and plaintiff's taxable costs and disburse-  
23 ments herein in the amount of \$286.00, which Judgment is entered  
24 in Skamania County, Superior Court, Cause No. 6973; and

25 Whereas, the Judgment is a foreclosure against the defendant  
26 Betty E. Jones of an Assignment of Real Estate Contract and Deed  
27 of real estate in Skamania County, Washington, described as follows:

28 Lots 12 and 13 of Block Three of Riverview
