8 the following statement:

9 That I, DONALD WILLIAM BARKER, am the father of two minor

29 understanding that the said custodial parents, BASIL R. SANDERS
30 and CHARLESIA SANDERS, husband and wife, do hereby agree to take
31 care of the wants, medical care, maintenance and education of my
32 said children.

1 It is further understood by and between myself and BASIL R.
 2 SANDERS and CHARLESIA SANDERS, husband and wife, that I am
 3 giving this consent for custody of the said children unto BASIL R.
 4 SANDERS and CHARLESIA SANDERS, husband and wife, freely and
 5 voluntarily and of my own voluntary act and deed.

6 I further state that I have read the foregoing and know the
 7 contents thereof and freely avow that this consent is given by
 8 me of my own free and voluntary will.
