CLAIM OF LOGGER'S LIEN

NOTICE IS HEREBY GIVEN that LEON R. SCOTT of Shelton, Mason County, State of Washington, claims a lien upon ten million board feet of logs which were cut, felled and bucked in Skamania County, State of Washington, and are now lying on the areas described in Exhibits A, B, and C which are attached hereto and incorporated herein by this reference.

Said lien is for labor performed upon and assistance rendered in cutting, felling, and bucking said timber and logs; that the name of the owner or reputed owner of the lands described on Exhibits A, B, and C, and the owner of the logs is Bald Knob Land and Timber Company, Portland, Oregon; that Morse Logging and BB & N Logging employed this lien claimant to perform such labor and render such assistance upon the following terms and conditions:

That the said BB & N Logging agreed to pay this lien claimant \$14.00 per thousand board foot of timber cut and felled for his labor and assistance hereinabove described; that the said Morse Logging agreed to pay this lien claimant \$16.00 per thousand board foot of timber cut and felled for his labor and assistance hereinabove described; that said contracts have been faithfully performed and fully complied with on the part of this lien claimant commencing April 19, 1982, and continuing to October 30, 1982. Thirty (30) days have not elapsed since October 30, 1982.

The following is a schedule of the work performed and the payments made on account of said services:

That based on the foregoing, there is now due and remaining unpaid after deducting all just credits and offsets, including credit for a claim of lien filed herewith by James Scott, the sum of \$85,950.00 for which amount this lien claimant claims a lien upon all logs lying upon the lands described on Exhibits A, B, and C, to secure the payment for the work and labor performed by this lien claimant in cutting, felling and bucking said timber and logs.

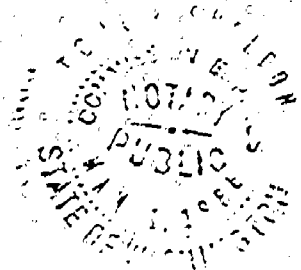

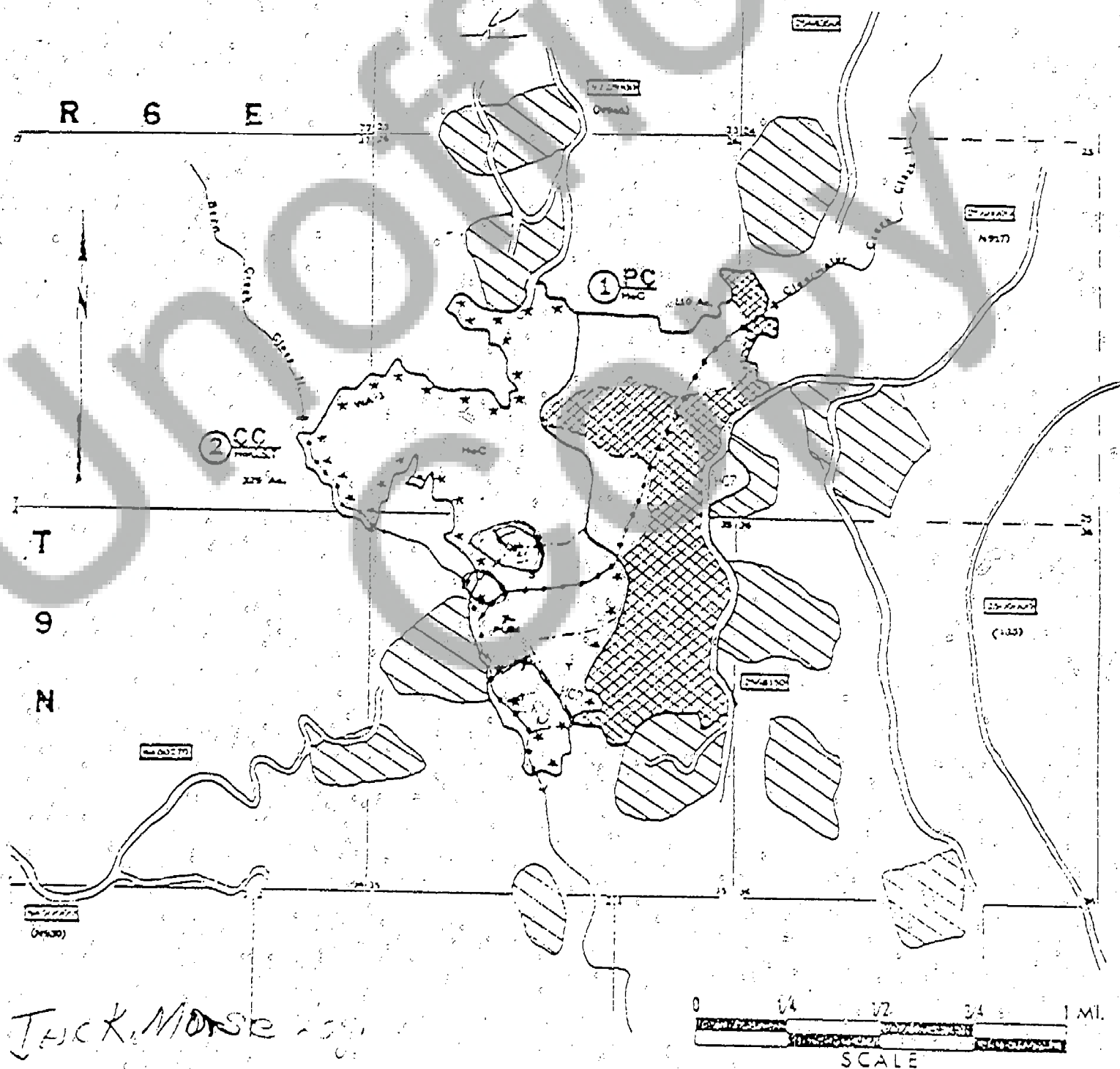
SALE AREA MAP AND SLASH DISPOSAL MAP

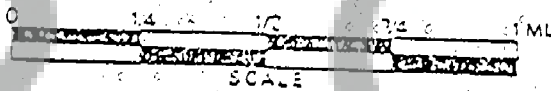
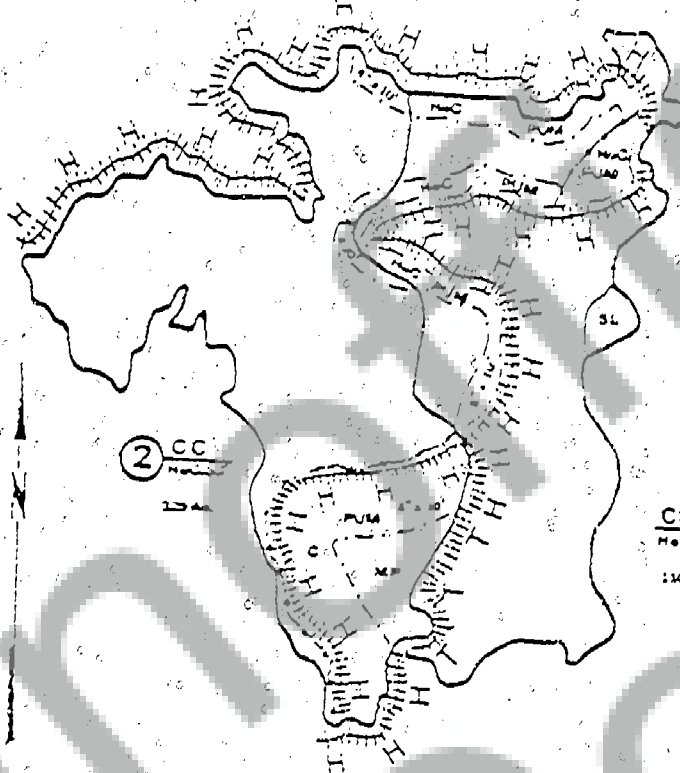

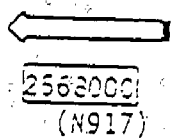


SALE AREA MAP AND SLASH DISPOSAL MAP

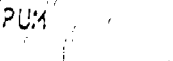

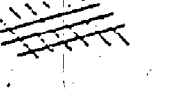

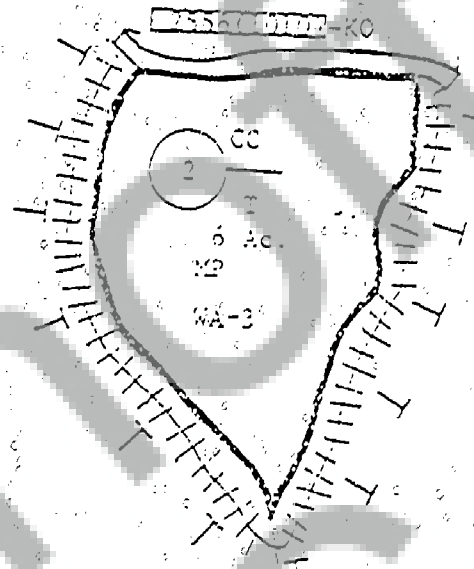
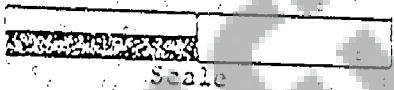
SALE AREA MAP AND SLASH DISPOSAL MAP

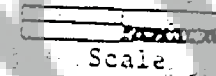

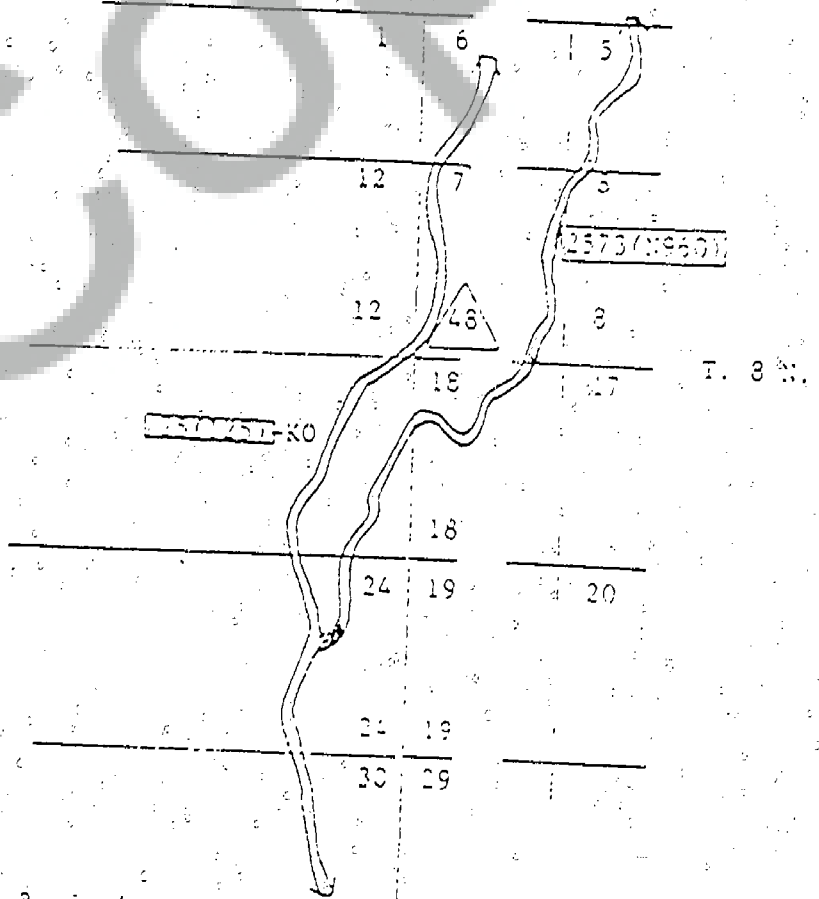


ROCK SOURCE MAP
