Notice is hereby given that Shoestring Timber Cutting, a

Partnership composed of David Storlie and Duane Stone (hereinafter referred to as "Contractor") of Kittitas County, State of Washington, claims a lien upon all saw logs, peelers or other timber and any manufactured lumber therefrom, said logs being orginally cut down in Skamania County, State of Washington, and transported to West Coast Orient Lumber Company in Spanaway, Pierce County, State of Washington, and which cut timber was marked _______, and is now lying in Skamania County on Unit No. 1 of the U.S. Forest Service "Beech Quartz" timber sale, Contract No. 06821-4, located in Sections 3, 4, 9, 10, 14 and 15, Township 10 North, Range 6

East, W.M. Skamania County, or at the mill of West Coast Orient Lumber Company in Pierce County for labor performed upon and assistance rendered in falling and bucking of timber;

That the name of the owner or reputed owner (or who will become the owner) is Bald Knob Land and Timber Company, P.O. Box 309, North Bend, Oregon 97459, hereinafter referred to as "Owner";

That Owner employed said Contractor to perform such labor and render such assistance upon the following terms and conditions, to-wit:

The said Owner agreed to pay the said Contractor for such labor and assistance \$28.00 per thousand net Scribner scale for merchantable logs and \$22.40 per thousand net Utility scale for utility logs;

That the said contract has been faithfully performed and fully complied with on the part of said Contractor, who performed labor upon and assisted in falling and bucking of said timber for the period of September 21, 1981 through December 15, 1982; said latter date being the last date of service and thirty days have not elapsed since that time;

That the amount of claimant's demand for said service is \$16,300.00 remaining and that is now due and owing unpaid thereon and which amount claimant claims a lien upon the aforementioned materials.

In addition thereto, claimant claims a lien upon the aforementioned materials resulting from labor performed and assistance rendered in hauling of timber as a result of Contractor being employed by Carlson and Gay Logging, Inc. who on behalf the Owner agreed to pay the Contractor \$4,870.40 for hauling timber from said sale to Kalama Boom and R.S.D. in Cowlitz County and West Coast Orient Lumber Company in Pierce County, which contract has been faithfully performed and fully complied with on the part of said Contractor and the amount of claimant's demand for said service is \$4,870.40 and that said sum is now due and owing and unpaid thereon and which amount claimant claims a lien upon the aforementioned materials.

The said claimant also claims a lien upon all said timber, lumber or stumpage now owned or to be owned by said Owner to secure payment for the work, hauling and labor performed in obtaining or securing the said logs, peelers or lumber herein described above.
