THE STATE OF WASHINGTON TO THE SHERIFF OF SKAMANIA COUNTY:

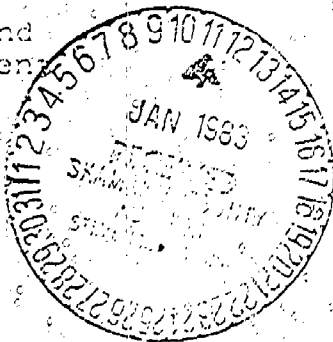

TOGETHER WITH AN EASEMENT FOR PURPOSES OF INGRESS AND EGRESS 30.00 FEET IN WIDTH ACROSS THE SOUTHEAST CORNER OF SAID DILLINGHAM SHORT PLAT AS SHOWN ON SAID SHORT PLAT MAP.
