

AMENDMENT TO LEASE

WHEREAS a Lease Agreement was made and entered into the 15th day of December, 1979, by and between Sam G. Melonas and Rita Melonas, husband and wife, therein known as Lessors, and Riverprise, Inc. a Washington corporation, therein known as Lessees,

AND WHEREAS the Lessees interest has been assigned to Wallace C. Cobine and approved by Lessors,

AND WHEREAS, the parties each desire to clarify the status of the building erected upon the property described in said lease, now therefore in consideration of mutual conditions, covenants and benefits contained herein, the parties agree as follows:

1. Lessee covenants that at the expiration of the term of this lease, he will quit and surrender said premises in a good and undamaged condition, ordinary wear and tear accepted.

2. All improvements thereon, including the building, fixtures, and equipment contained therein, shall remain the property of the Lessee, which shall be removed by Lessee within 30 days of the termination of said Lease or any renewal thereof or within 30 days of the vacation of the premises by Lessee. In the event Lessee fails to remove the building and its contents within said 30 days, said building and contents shall revert to the ownership of Lessor.




