

AGREEMENT OF MODIFICATION
FOR ASSUMPTION PURPOSES

It is mutually understood and agreed between Vancouver Federal Savings and Loan Association, a Corporation, hereinafter termed MORTGAGEE, and

JEFFREY F. CLOUTIER AND KAREN A. CLOUTIER, husband and wife
GRANTEE of the mortgagor, and

THOMAS J. TUCKER AND CORRINE A. TUCKER, husband and wife
who is hereinafter referred to as MORTGAGOR, based upon due and sufficient con-

sideration each to the other moving, all as follows:

That beginning April 1, 1983 that certain note and mortgage,

given by the mortgagor to the mortgagee, being the latter's Loan No. 530-00506.

shall be modified in the following respects:

Consistent with the provision in the mortgage that the Mortgagee shall have the right to increase the interest rate by not to exceed 2% in annual rate upon conveyance by the Mortgagors to a third party, the parties hereto agree that the interest rate in the note secured by the aforesaid mortgage is hereby increased to 11 1/4 % per annum and the monthly payment, exclusive of taxes and insurance is increased to \$ 1,297.14 per month, the entire indebtedness to be paid on or before the date set forth in the note.

No provision of this modification shall prevent the mortgagee from exercising any provision of the original mortgage and each and every other provision of said mortgage shall remain in full force and effect.

All parties hereto continue fully responsible for performance of the terms of the note and mortgage securing said note.

The word "mortgagor" includes "mortgagors."






