PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That IRWIN P. JESSEN, a single man the owner and holder of that certain mortgage bearing date the 8th day of Feb. 1978 executed by W. JACK & GEORGENE SPRINKEL to secure payment of the sum of ELEVEN THOUSAND Dollars and interest, and recorded in the office of the County Auditor of Washington, on the 15th day of Sept. 1978 in Volume 55 of Mortgages, at page 798 being Auditor's File No. 87226 do hereby release and discharge from the lien of said mortgage the following described lands situate in the County of SKAMANIA State of Washington, to-wit: A portion of the Southwest quarter of the Northeast quarter of Section 34, Township 2 North, Range 5 East, Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a 5/8" iron rod at the Northwest corner of said Southwest quarter of the Northeast quarter of Section 34; thence South 47° 52' 13" East, 965.07 feet to the West right-of-way line of a 60 foot easement; THENCE following said West right-of-way line South 55° 00' 00" West, 195.46 feet; THENCE along the arc of a 150 foot radius curve to the left for an arc distance of 127.85 feet; THENCE South 06° 10' 00" West, 12.29 feet; THENCE along the arc of a 470 foot radius curve to the right for an arc distance of 123.05 feet; THENCE South 21° 10' 00" West, 34.16 feet; THENCE leaving said West right-of-way line North 89° 00' 00" West, 471.39 feet to the West line of the Southwest quarter of the Northeast quarter; THENCE North 01° 12' 11" East, 1021.55 feet to the POINT OF BEGINNING:

ALSO: BEGINNING at a point on the East line of the Northwest quarter of the Southeast quarter of Section 34; South 01° 11' 49" West, 364.73 feet from the Northeast corner thereof; thence South 01° 11' 49" West along said East line, 319.11 feet; THENCE South 60° 40' 00" West, 202.65 feet; THENCE North 80° 20' 00" West, 846.54 feet to a point in the centerline of a 60 foot road easement; THENCE North 89° 00' 00" West, 807.54 feet to the West line of said Northwest quarter of the Southeast quarter; THENCE North 01° 12' 11" East along said West line, 270.87 feet; THENCE North 90° 00' 00" East, 1319.66 feet to the POINT OF BEGINNING: SUBJECT TO easements and restrictions of record; TOGETHER WITH AND SUBJECT TO that certain road easement as described in Skamania County Deed Records.

But this release shall not impair the validity of said mortgage as to the other lands therein described.
