DESCRIPTION

PARCEL A

THE FOLLOWING DESCRIBED REAL PROPERTY LOCATED IN SKAMANIA COUNTY, STATE OF WASHINGTON, TO WIT:

BEGINNING AT THE INTERSECTION OF THE CENTER OF THE CHANNEL OF ROCK CREEK WITH THE SOUTH LINE OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 7 EAST OF THE WILLAMETTE MERIDIAN; THENCE EAST TO A POINT 4.39 CHAINS WEST TO THE QUARTER CORNER ON THE SOUTH LINE OF THE SAID SECTION 36; THENCE NORTH $05^{\circ} 30'$ WEST 662.5 FEET, MORE OR LESS, TO THE NORTH BOUNDARY OF THE TOWN OF STEVENSON; THENCE WEST TO THE CENTER OF THE CHANNEL OF ROCK CREEK; THENCE FOLLOWING THE CENTER OF THE CHANNEL OF ROCK CREEK SOUTHERLY TO THE POINT OF BEGINNING;

EXCEPT A TRACT OF LAND CONVEYED TO P.E. MICHELL BY DEED RECORDED AT PAGE 159 OF BOOK "S" OF DEEDS, RECORDS OF SKAMANIA COUNTY, WASHINGTON;

AND EXCEPT THE FOLLOWING DESCRIBED TRACT: BEGINNING AT THE SOUTHEAST CORNER OF THE TRACT FIRST ABOVE DESCRIBED; THENCE ALONG THE SOUTH LINE OF THE SAID SECTION 36 WEST 225 FEET TO THE INITIAL POINT OF THE TRACT HEREBY EXCEPTED; THENCE NORTH 275 FEET; THENCE WEST TO THE CENTER OF THE CHANNEL OF ROCK CREEK; THENCE FOLLOWING THE CENTER OF THE CHANNEL OF ROCK CREEK SOUTHERLY 275 FEET, MORE OR LESS, TO THE SOUTH LINE OF THE SAID SECTION 36; THENCE EAST TO THE INITIAL POINT.

PARCEL B

BEGINNING AT A POINT ON THE SOUTH LINE OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 7 EAST OF THE WILLAMETTE MERIDIAN, WEST 4.39 CHAINS FROM THE QUARTER CORNER ON THE SOUTH LINE OF THE SAID SECTION 36; THENCE ALONG THE SOUTH LINE OF THE SAID SECTION 36 WEST 225 FEET TO THE INITIAL POINT OF THE TRACT HEREBY DESCRIBED; THENCE NORTH 275 FEET; THENCE WEST TO THE CENTER OF THE CHANNEL OF ROCK CREEK; THENCE FOLLOWING THE CENTER OF THE CHANNEL OF ROCK CREEK SOUTHERLY 275 FEET, MORE OR LESS, TO THE SOUTH LINE OF THE SAID SECTION 36; THENCE EAST TO THE INITIAL POINT.

EXCEPT COMMENCING AT A POINT 73 FEET NORTHEAST FROM THE NORTHEAST CORNER OF THE EAST TRUSS OF THE ROCK CREEK BRIDGE ON THE NORTH SIDE OF THE VANCOUVER ROAD; THENCE RUNNING AT RIGHT ANGLES 100 FEET IN A NORTHWESTERLY DIRECTION TO A LARGE BOULDER 2 FEET HIGH; THENCE IN A SOUTHWESTERLY DIRECTION AT RIGHT ANGLES 73 FEET; THENCE IN A SOUTHEASTERLY DIRECTION AT RIGHT ANGLES 100 FEET TO THE EAST TRUSS OF ROCK CREEK BRIDGE; THENCE NORtheASTERLY ALONG THE NORTH LINE OF VANCOUVER ROAD TO THE PLACE OF BEGINNING; BEING THAT CERTAIN TRACT OF LAND CONVEYED TO GRANT BALLARD BY DEED RECORDED AT PAGE 250 OF BOOK "N" OF DEEDS, RECORDS OF SKAMANIA COUNTY, WASHINGTON.
