PARTIAL SATISFACTION OF MORTGAGE BOOK 59 PAGE 338

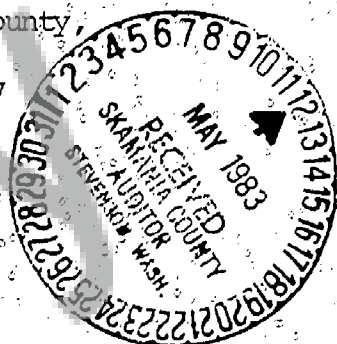

JACK SPRINKEL and GEORGENE SPRINKEL, husband and wife, to secure the payment of the sum of ONE HUNDRED NINETY-THREE THOUSAND ONE HUNDRED TWENTY AND NO/100 (\$193,120.00) and interest, and which mortgage is recorded in the office of the Auditor of Skamania County, Washington on January 17, 1978, in Book 55 of Mortgages, page 66, FOR VALUE RECEIVED, do hereby release and discharge from the lien of said mortgage the following described portion of the mortgaged premises, situated in Skamania County, Washington, to-wit:

A portion of the Northwest quarter of the Southeast quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, more particularly described as follows:

BEGINNING at a point on the East line of the Northwest quarter of the Southeast quarter of Section 34, South 01°07'38" West, 347.25 feet from the Northeast corner thereof; thence South 01°07'38" West along said East line 320.47 feet; thence South 60°40'00" West, 199.87 feet; thence North 80°20'00" West, 846.54 feet to a point in the centerline of a 60-foot road easement; thence North 89°00'00" West 312.50 feet to the West line of said Northwest quarter of the Southeast quarter; thence North 01°03'40" East along said West line 270.77 feet; thence North 90°00'00" East, 1322.50 feet to the point of beginning.

TOGETHER WITH and SUBJECT TO that certain easement as described under Auditor's File Nos. 85612, 85614 and 86117, Skamania County, Washington.

SUBJECT TO electric transmission line easement, if any, as now appearing of record.



This release shall not impair the lien of said mortgage as to the property described therein except as specifically released hereby.

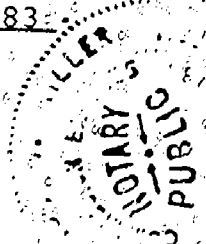
