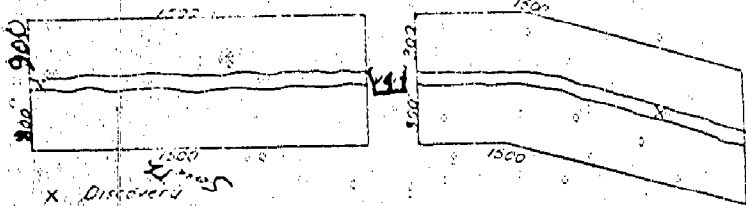

NOTICE IS HEREBY GIVEN That the undersigned who is/are (has/declared intention to become) citizen of the United States, has discovered and has located and claimed and do hereby locate 1500 linear feet in length, and 1800 feet in width on the Yellow Jacket River Rd. 2810-051 Township E9. Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 900 feet in a North direction to an end post marked No. 2, thence 1500 feet in a East direction to a corner post marked No. 3, thence 900 feet in a South direction to a corner post marked No. 4, thence 900 feet in a South direction to a corner post marked No. 5, thence 1500 feet in a West direction to a corner post marked No. 6, thence 900 feet in a North direction to said end post No. 2; hereby locating and intending to claim 1500 feet in a East direction from discovery to the East end line, and 0 feet in the opposite direction from discovery to the 051 Rd. end line and 900 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.

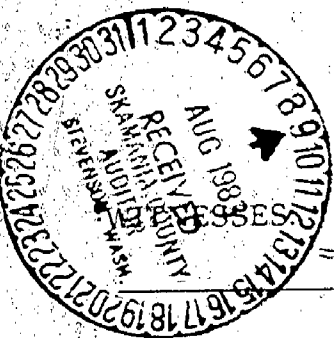
This claim is further described by reference to natural objects or permanent monuments as follows:
