

STATEMENT OF ANNUAL LABOR FOR THE YEAR
ENDING AUGUST 31, 1983

Useful work and improvements in the amount of more than \$42,700 were done and made during the period from August 31, 1982 to October 31, 1982 by Diamond Drilling Contracting Co., P. O. Box 11307, Spokane, Washington 99211, at the request of Plexus, Incorporated (formerly Croesus Resources, Inc.), whose address is 175 South West Temple, Suite 780, Salt Lake City, Utah 84101 for all of the lode mining claims listed in attached "Exhibit C", located in the Copper Creek mining district, Skamania County, Washington, T.3 N., R.5 E., W.M., in Sections 3, 4, 5, 8, 9, and 10; and T.4 N., R.5 E., W.M. in Sections 27, 28, 29, 32, 33, and 34.

A total of 207 contiguous mining claims are included in this statement. Work and improvements required more than 120 man-days of labor, consisting of 1,952 feet of diamond core drilling completed in four holes, as follows:

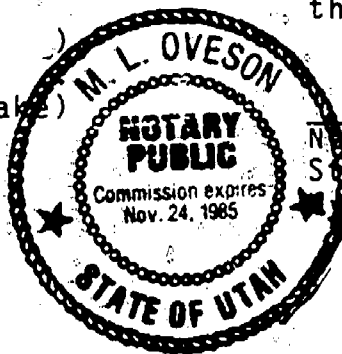

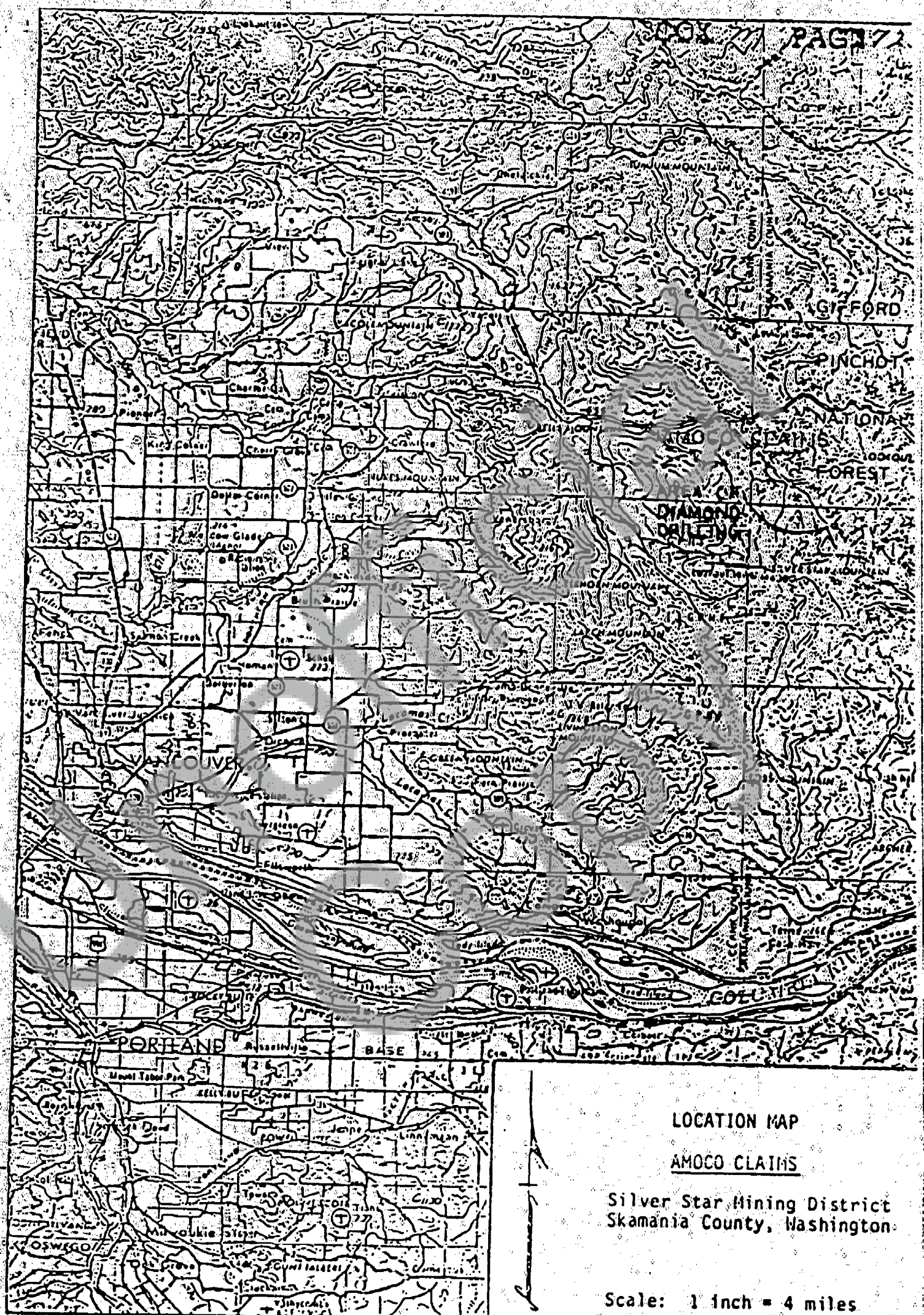
