LOAN MODIFICATION AGREEMENT

This agreement made and entered into this day of <u>September</u>, 19<u>83</u> by and between RIVERVIEW SAVINGS ASSOCIATION (hereinafter called "Lender"), and Richard A. Beard and Selina M. Beard, husband & wife, (hereinafter called "Owner").

WHEREAS, Lender loaned RICHARD A. BEARD and SELINA M. BEARD. Name of Original Borrower the sum of TWELVE TEOUSAND AND NO/100- - - - - Dollars (\$12,000.00- -), as evidenced by a note and mortgage (the term "mortgage" includes a Deed of Trust) executed and delivered on september 6, 1983 which mortgage is duly recorded under Auditor's File No. 10359 5/2/2 in the public records in the jurisdiction 5427 in the public records in the jurisdiction where the mortgaged property is located which note and mortgage are hereby incorporated herein as part of this instrument: and

WHEREAS, the undersigned owner of said premises has found it necessary and does hereby request a modification of the terms of said loan for the following reasons:

Lender has agreed to_reduce the interest rate to 11.875% per annum with the principal and interest payment of \$171.30 effective for the first loan period. The first loan period will expire March 1, 1985, at which time the interest rate will be adjusted to the then current market rate, using the Index as explained in paragraph four (4) "Interest Rate Change" on the Adjustable Rate Note.

WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, in consideration of the reasons stated above, as of the date of this agreement the unpaid balance of said indebtedness is TWELVE THOUSAND AND NO/100- ---- Dollars (\$12,000.00--), all of which the undersigned promises to pay with interest at 11.875% per annum until paid, and that the same shall be payable ONE HUNDRED SEVENTY ONE AND 30/100- -- Dollars, (\$ 171.30 --) per month beginning on the 1st day of october , 1983 to be applied first to interest, and balance to principal, plus a sum estimated to be sufficient to discharge taxes and insurance obligations, if applicable, (which estimated sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.
