ANDERSEN, of Carson, Skamania County, Washington, herein referred to and acting as executor of the Estate of ELLA R. ANDERSEN, deceased, and HAROLD ANDERSEN, of Carson, Skamania County, Washington, herein referred to as grantee:

The parties recite and declare that:

1. On September 6, 1974, Ella R. Andersen executed her will disposing of all of her property. Ella R. Andersen died on November 2, 1981, and her will was duly admitted to probate by proper order of the Superior Court of the County of Skamania, State of Washington.
2. By the terms of the will, in Paragraph Seven, certain residuary property rights and interest were devised to said grantee.
3. The will conferred on Herbert R. Andersen, as executor, general authority to sell and dispose of any portion of the estate and to execute conveyances thereof.
4. The interest in the real estate of Ella R. Andersen vested or to be vested in grantee by virtue of Paragraph Seven of the will is of the reasonable value of Eight Hundred Ninety Dollars (890.00).

In consideration of the premises the executor of the estate of Ella R. Andersen, deceased, conveys to grantee all that certain land and premises described as follows:

One one-hundredth undivided interest in 20 acres of real property located in Skamania County, Washington, and more particularly described as follows: From the Northeast corner of Northwest Quarter of Northeast Quarter of Section 20, Township 3 North, Range 8 East of the Willamette Meridian, South 82 rods for point of beginning, thence West 80 rods, South 40 rods, East 80 rods, North 40 rods to point of beginning.

To have and to hold the above-described premises, together with the rights and appurtenances thereto to grantee, his heirs and
