The parties recite and declare that:

1. On September 6, 1974, Ella R. Andersen executed her will disposing of all of her property. Ella R. Andersen died on November 2, 1981, and her will was duly admitted to probate by proper order of the Superior Court of the County of Skamania, State of Washington.

2. By the terms of the will, in Paragraph Seven, certain residuary property rights and interest were devised to said grantee.

3. The will conferred on Herbert R. Andersen, as executor, general authority to sell and dispose of any portion of the estate and to execute conveyances thereof.

4. The interest in the real estate of Ella R. Andersen vested on to be vested in grantee by virtue of Paragraph Seven of the will is of the reasonable value of Eight Hundred Ninety Dollars (\$890.00).

In consideration of the premises the executor of the estate of Ella R. Andersen, deceased, conveys to grantee all that certain land and premises described as follows:

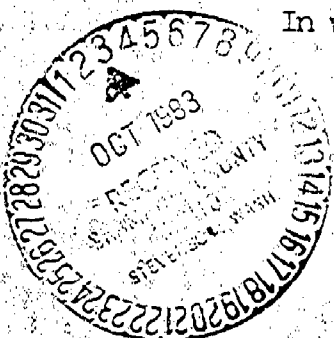

To have and to hold the above-described premises, together with the rights and appurtenances thereto to grantee, her heirs and assigns forever.

Grantee by accepting this deed, acknowledges receipt from the estate of Ella R. Andersen of her full share and interest of the real estate therein.
