 Originally set by John Truten during 1857 G.L.O. survey. Restored in 1908 with Skamania County iron pipe and cap. County records indicate that 2 B.T. snags were found during 1908 survey. Pipe used in 1971 unrecorded Dept of Game survey and 1979 Alpha Engineers survey filed in Book 10 page 199.
- Description of Evidence Found:
 Above mentioned Skamania County iron pipe and cap set in a monument case 3" below surface of Alder Road, 63.8 ft south of centerline of Buhman Road and 34.6 ft West of Line Crossing Post. Held for corner.
 Accepted corner.
