- 2. Tax Lot 1590 survey c.1971 by Eldridge, who set the 1/16 corner for that lot's description. Not accepted.
- 3. Found iron pipe set for this corner to be on County property. Accepted for line only, as position fits original intent at fenceline.
- 4. Roadway easement is described as being across the South 20 feet of Tax Lot 500.
- 5. Centerline of Little Buck Creek Reed calculated to be \$ 89°28'48" E 32.48 feet from the southwest corner of Tax Lot 900.
- 6. Well and cistern found to be on State land by 1982 DNR survey, 50° \times 50° easement shown is perallel with and perpendicular to the north-south centerline of the Section.
