Lender has agreed to reduce the interest rate to 11.875% per annum with the principal and interest payment of \$218.48 effective for the first loan period. The first loan period will expire March 1, 1985, at which time the interest rate will be adjusted to the then current market rate, using the Index as explained in paragraph four (4) "Interest Rate Change" on the Adjustable Rate Note.
