## PARCEL I

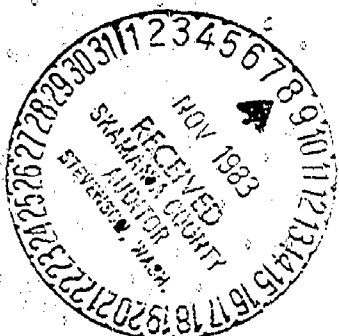
All timber bounded by the 467 Road, logged areas and clearcut boundary tags on part of the southwest quarter of Section 25, Township 7 North, Range 6 East, W.M., and more fully described in Department of Natural Resources Application No. 41823.

## PARCEL II

All timber bounded by clearcut boundary tags, property lines and logged areas on part of the west half of the northeast quarter and part of the east half of the northwest quarter of Section 24, Township 7 North, Range 6 East, W.M., and more fully described in Department of Natural Resources Application No. 41821.

In the event that the subject timber is not removed within a period of five (5) years from the date hereof, an additional period of time to remove said timber may be obtained by State of Washington paying or causing to be paid to Publishers Forest Products Co. of Washington, its successors or assigns, the standard State of Washington extension fee for loss of land productivity. Slash disposal and reforestation shall be the responsibility of State of Washington.
