DESCRIPTION

THE FOLLOWING DESCRIBED REAL PROPERTY LOCATED IN SKAMANIA COUNTY, STATE OF WASHINGTON, TO-WIT:

A TRACT OF LAND LOCATED IN THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 29, TOWNSHIP 3 NORTH, RANGE 8 EAST OF THE WILLAMETTE MERIDIAN, DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE CENTERLINE OF COUNTY ROAD NO. 2045, DESIGNATED AS THE CARSON CREEK ROAD WITH THE WESTERLY LINE OF WILKINSON STREET AS SHOWN ON THE PLAT OF BOYD & WILKINSON'S ADDITION TO CARSON ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE AND OF RECORD AT PAGE 36 OF BOOK "A" OF PLATS, RECORDS OF SKAMANIA COUNTY, WASHINGTON; THENCE SOUTH ALONG THE WESTERLY LINE OF SAID WILKINSON STREET 425 FEET TO THE INITIAL POINT OF THE TRACT HEREBY DESCRIBED; THENCE SOUTH ALONG SAID WESTERLY LINE 200 FEET; THENCE WEST 200 FEET; THENCE NORTH PARALLEL TO THE WESTERLY LINE OF SAID WILKINSON STREET 200 FEET; THENCE EAST 200 FEET TO THE INITIAL POINT.
