AUDITOR'S RECORDING NUMBER

FOREST LAND means and is synonomus with timberland and means all lands in any contiguous ownership of 20 or more acres, which is primarily devoted to and used for growing and harvesting timber and means land only

CLASSIFIED is land whose highest and best use is the growing and harvesting of timber.

DESIGNATED is land which is primarily devoted to and used for growing and harvesting timber but whose value for other purposes may be greater than its value for use as forest land.

Upon removal of classified or designated forest land accompensating tax shall be imposed upon the land based on the collowing procedure:
