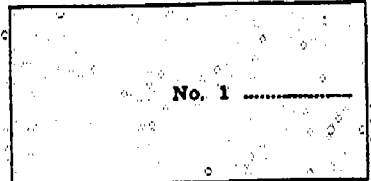

 and 600 feet in width on the Lode

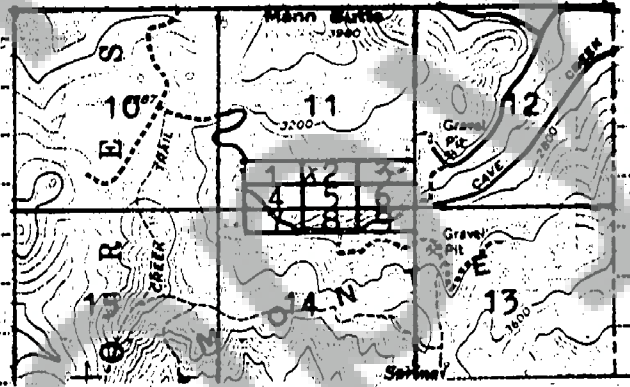

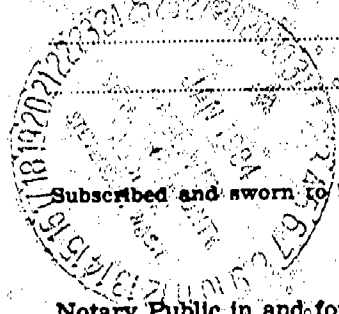
