## PURCHASE AGREEMENT OF CORPORATE STOCK

This CONTRACT entered into this 27th day of February, 1984 between Wesley A. Ober, JR: hereafter deferred to as SELLER, and CIRCLE H-B, INC., a Washington Corporation hereafter referred to as BUYER.

- B.) In case suit or action is instituted to collect this CONTRACT, or any portion thereof, BUYER promises to pay such additional sum as the court may adjudge reasponable as attormey's rees in said suit or action.
