

## NOTICE OF MINING LOCATION

NOTICE IS HEREBY GIVEN, That the undersigned locator has discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain within the State of Washington and in accordance with the laws of the United States, of the State of Washington and regulations of said mining district, has located and does hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post at the point of discovery, marked Post 1 and further described as follows:

Commencing at a post marked No. 1 (Discovery Post), from thence 600 feet in a southerly direction to an end post marked No. 2, thence 300 feet in a westerly direction to a corner post marked No. 3, thence 1500 feet in a northerly direction to a corner post marked No. 4, thence 600 feet in a easterly direction to a corner post marked No. 5, thence 1500 feet in a southerly direction to a corner post marked No. 6, thence 300 feet in a westerly direction to said end post No. 2; hereby locating and intending to claim 600 feet in a southerly direction from discovery to the south end line, and 900 feet in the opposite direction from discovery to the north end line, and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as Township 4 North, Range 8 East of the Willamette Meridian, Section 25.
