NOTICE IS HEREBY GIVEN, That the undersigned locator has discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain within the State of Washington and in accordance with the laws of the United States, of the State of Washington and regulations of said mining district, has located and does hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post at the point of discovery, marked Post 1 and further described as follows:

Commencing at a post marked No. 1 (Discovery Post), from thence 600 feet in an easterly direction to an end post marked No. 2, thence 300 feet in an northerly direction to a corner post marked No. 3, thence 1500 feet in a westerly direction to a corner post marked No. 4, thence 300 feet in a southerly direction to a center post marked No. 5, thence 300 feet in a southerly direction to a corner post marked No. 6, thence 1500 feet in an easterly direction to a corner post marked No. 7; thence 300 feet northerly to said end post marked No. 2; hereby locating and intending to claim 600 feet in an easterly direction from discovery to the east end line, and 900 feet in the opposite direction from discovery to the east end line, and 300 feet on each side fo the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as Township 4 North, Range 8 East of the Willamette Meridian, Section 24.

This notice is placed at Discovery on Post No. 1; posts are placed at each corner, and the name of this lode and date of location are placed on all posts.
