(7) The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deliver to

perchaser a statutory warranty fulfillment deed to said real estate, excepting any part thereof hereafter taken for public use; free of encumbrances except any that may attach after date of closing through any person other deed to said real estate, excepting any than the seller, and subject to the following:

Service upon purchaser of all demands notices or other papers with respect to forfeiture and termination of purchaser's rights may be made by United States Mail, postage pre-paid returning ceipt requested, directed to the purchaser to his address last known to the seller.

(11) Upon seller's election to bring suit to enforce any covenant of this contract including suit to collect any payment required hereunder, the purchaser agrees to pay a reasonable sum as attorney's fees and all costs and expenses in connection with such suit, which sums shall be included in any judgment or decree entered in such suit.


