EXECUTOR'S DEED

Deed made June 14, 1984, between HERBERT R. ANDERSEN, of Carson, Skamaria County, Washington, herein referred to and acting as Executor of the Estate of Celo G. Andersen, deceased, and HERBERT R. ANDERSEN, of Carson, Skamania County, Washington, herein referred to as grantee.

The parties recite and declare that:

- 1. On September 6, 1974, Celo G. Andersen executed his will disposing of all of his property. Celo G. Andersen died on August 24, 1983, and his will was duly admitted to probate by proper order of the Superior Court of the County of Skamania, State of Washington.
- 2. By the terms of the will, in Paragraph Three, certain residuary property rights and interest were devised to said grantee.
- 3. The will conferred on Herbert R. Andersen, as executor, general authority to sell and dispose of any portion of the estate and to execute conveyances thereof.

One-tenth undivided interest in real property located in Skamania County, Washington, and more particularly described as follows:

West Half of the East Half of the Northwest Quarter of Southwest Quarter of Section 26, Township 4 North, Range 7 East of the Willamette Meridian.

To have and to hold the above-described premises, together with the rights and appurtenances thereto to grantee, his heirs and assigns forever.

Grantee by accepting this deed, acknowledges receipt from the estate of Celo 3. Andersen of his full share and interest of the real estate therein.
