2.4 Removal of Improvements. Grantor shall not demolish or remove any improvements from the Real Property without the prior written consent of Lender, Lender shall consent if Grantor makes arrangements satisfactory to Lender to replace any improvement which Grantor proposes to remove with one of at least equal value. "Improvements" shall include all existing and future buildings, structures, and parking facilities.

2.5 Lender's Right to Enter. Lender and its agents and representatives may enter upon the Property at all reasonable times to attend to Lender's interest and to inspect he Property.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and Lender's interest in the Property is not jeopardized. Lender may require Grantor to post adequate security (reasonably satisfactory to Lender) to protect

Duty to Protect. Granter shall do all other acts, in addition to those set forth in this section, that from the character and use of the Property are

Teasonably necessary to protect and preserve the security.

Construction Loan. If some or all of the proceeds of the loan creating the Indebtedness is to be used to construct or complete construction of any Improvement on the Property, the Improvement shall be completed within six months from the date of this Deed of Trust and Grantor shall pay in full all costs and expenses in connection with the work.

Taxes and Liens.

Payment. Grantor shall repair or replace the damaged or destroyed Improvements in a manner satisfactory to Lender Lender shall, upon assisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. If Lender holds any proceeds after payment in full of the Indebtedness, such proceeds shall be paid to Grantor.

Unexpired Insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Deed of Trust at any trustees or other sale held under the provision contained within, or at any foreclosure sale of such Property.

Compliance with Prior Indebtedness. During the period in which any prior indebtedness described in Section 17.1 is in effect, compliance with the insurance provisions contained in the instrument evidencing such prior indebtedness shall constitute compliance with the insurance provisions contained in the instrument evidencing such prior indebtedness shall constitute compliance with the insurance provisions under this Deed of Trust to the extent compliance with the terms of this Deed of Trust would constitute a duplication of insurance requirement. Insurance Reserves. Subject to any limitations set by applicable law. Expenditure By Lender. Grantor fails to comply with any provision of this Deed of Trust, including the obligation to maintain the prior indebtedness in good standing as required by Section 17 hereunder, or if any action or proceeding is commenced that would materially affect Lender synterest in the property. Lender may at its option on Grantor's behalf take the required action and any amount that it expends in so doing shall be added to the Indebtedness and bear interest at the rate the Note bears. Amounts so added shall be payable on demand with interest from the date of expenditure at the rate the Note bears. The rights provided for in this section shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. By taking the required action,

Lender shall not cure the default so as to bar it from any remedy that it otherwise would have had. Warranty: Defense of Title.

Title Grantor warrants that it holds merchantable title to the Property in fee simple free of all encumbrances other than those set forth in Section 17 or in any policy of title insurance issued in favor of Lender in connection with this Deed of Trust:

Defense of Title. Subject to the exceptions in the paragraph above, Grantor warrants and will forever defend the title against the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Lender or Trustee under this Deed of Trust, Grantor shall defend the action at its expense.

Condemnation.

- Application of Net Proceeds. If all or any part of the Property is condemned. Lender may at its election require that all or any portion of the net proceeds of the award be applied to the Indebtedness. The net proceeds of the award shall mean the award after payment of all reasonable costs. expenses, and attorneys fees necessarily paid or incurred by Grantor, Lender, or Trustee in connection with the condemnation.
- 7.2 Proceedings. If any proceedings in condemnation are filed. Grantor shall promptly notify Lender in writing and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award.

Imposition of Tax By State.

- State Taxes Covered. The following shall constitute state taxes to which this section applies:

  (a) A specific tax upon trust deeds or upon all or any part of the Indebtedness secured by a trust deed or security agreement.

  (b) A specific tax on a grantor which the taxpayer is authorized or required to deduct from payments on the Indebtedness secured by a deed of trust or security agreement.

Remedies: If any state tax to which this section applies is enacted subsequent to the date of this Deed of Trust; this shall have the same effect as a default, and Lender may exercise any or all of the remedies available to it in the event of a default unless the following conditions are met: (a) Grantor may law fully pay the tax or charge imposed by the state tax, and
(b) Grantor pays or offers to pay the tax or charge within 30 days after notice from Lender that the tax law has been enacted.

Power and Obligations of Trustee. Powers of Trustee. In addition to all powers of Trustee arising as a matter of law. Trustee shall have the power to take the following actions with respect to the Property upon the request of Lender and Grantor:

(a) Join in preparing and filing a map or plat of the Real Property, including the dedication of streets or other rights in the public.

Join in any subordination or other agreement affecting this Deed of Trust or the interest of Lender under this Deed of Trust.

(d) Sell the Property as provided under this Deed of Trust.

Obligations to No iffy. Trustee shall not be obligated to notify any other party of a pending sale under any other trust deed or lien, or of any action or proceeding in which Grantor, Lender, or Trustee shall be a party, unless the action or proceeding is brought by Trustee.

10. Pue on Sale.

10.1 Consent by Lende: Lender may, at its option, declare immediately due and payable all sums, secured by this Deed of Trust upon the sale or transfer of all or any part of the Real Property without the Lender's prior written consent. A "sale or transfer" means the conveyance of real property or any right, title, or interestiterein, whether legal or equitable, whether voluntary or involuntary, by outright sale, deed, installment sale contract, or any other method of conveyance of land contract, contract for deed, leasehold interest with a term greater than three years, lease-option contract, or any other method of conveyance of real property interests. If any Borrower is a corporation, transfer also includes any change in ownership of more than 25% of the voting stock of

(f) Grantor or prospective transferee applies to Lender for consent to a transfer, Lender may require such information concerning the prospective transferee as would normally be required from the new loan applicant.

### 11. Security Agreement: Financing Statements.

Security Agreement. This instrument shall constitute a security agreement to the extentiany of the Property constitutes fixtures, and Lender shall have all of the rights of a secured party under the Uniform Commercial Code of the state in which the Real Property is located.

- Security Interest. Upon request by Lender. Grantor shall execute financing statements and take whatever other action is requested by Lender to perfect and continue Lender's security interest in the Income and Personal Property. Grantor hereby appoints Lender as Grantor's attorney in fact for the purpose of executing any documents necessary to perfect or continue the security interest granted therein. Lender may at any time and without further authorization from Grantor file copies of reproductions of this Deed of Trust as a financing statement. Grantor will reimburse Lender for all expenses incurred in perfecting or continuing this security interest. Upon required may at any after receipt of written demand from Pender. to Lender within three days after receipt of written demand from Lender.
- 11.3 Mobile Homes. If the Property includes mobile homes, motor homes, modular homes, or similar structures, such structures shall be and shall remain Personal Property or Real Property as stated above regardless of whether such structures are affixed to the Real Property, and irrespective of the classification of such structures for the purpose of tax assessments. The removal or addition of axless or wheels, or the placement upon or removal from a concrete base, shall not alter the characterization of such structures.

## 12. Reconveyance on Full Performance.

If Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Grantor under this Deed of Trust and the Note. Lender shall execute and deliver to Trustee a request for full reconveyance in the form set forth on this Deed of Trust and shall execute and deliver to Grantor suitable statements of termination of any financing statement on file evidencing Lender's security interest in the Income and the Personal Property. Any reconveyance fee or termination fee required by law shall be paid by Grantor, if permitted by applicable law

The following shall constitute events of default:

Failure of Grantor to pay any portion of the Indebtedness when it is due.

(b) Failure of Grantor within the time required by this Deed of Trust to make any payment for taxes, insurance or for any other payment necessary to prevent filing of or to effect discharge of any lien

Dissolution or termination of existence (if Grantor is a corporation), insolvency, business fallure, appointment of a receiver for any part of the property of assignment for the benefit of creditors by the commencement of any proceeding under any bankruptcy or insolvency laws by or against, or the failure to obtain dismissal or deny the contents of any petition filed under any bankruptcy or insolvency laws within the time required to answer by. Grantor or any of the individuals or entities who are herein collectively referred to as "Grantor".

Default of Grantor under any prior obligation or instrument securing any prior obligation or commencement of any suit or other action to

foreclose any prior lien.

If the Real Property has been submitted to unit ownership pursuant to a Unit Ownership Law or any similar law, failure of Grantor to perform any of the obligations imposed on Grantor by the declaration submitting the Real Property to unit ownership, by the bylaws of the association of unit owners, or by any rules or regulations thereunder. If Grantor's interest in the Real Property is a leasehold interest and such Property has been submitted to unit ownership, any failure of Grantor to perform any of the obligations imposed on him by the lease of the Real Property from its owner, any default under such lease which might result in termination of the lease as it pertains to the Real Property, or any failure of Grantor as a member of an association of unit owners to take any reasonable action within Grantor's power to prevent a default under such lease by the association of anit owners or by any member of the association

Failure by Grantonto perform any other obligation under this Deed of Trust if:

(1) Lender has sen to Grantor a written notice of the failure and the failure has not been cured within 15 days of the notice, or if the default

cannot be cured within 15 days. Grantor has not commenced curative action or is not diligently pursuing such curative action; or (2) Grantor has given notice of a breach of the same provision(s) of this Deed of Trust within the preceding 12 months.

If the interest of Grantor in the Property is a casehold interest, any default by Grantor under the terms of the lease, or any other Event (whether or not the fault of Grantor) that results in the termination of Grantor's leasehold rights; provided, that such events shall not constitute a default hereunder if Grantor provides Lender with prior written notice reasonably satisfactory to Lender, setting forth Grantor's intent to place the Personal Property at another location, stating the location, and evidencing Grantor is right to do so.

Any breach by Grantor under the terms of any other agreement between Grantor and Lender that is not remedied within any grace period provided therein, including without limitation any agreement concerning any indebted less of Grantor to Lender, whether made now or later

vided therein, including without limitation any agreement concerning any indebtedriess of Grantor to Lender, whether made now or later.

If Lenderreasonably deems itself insecure.

## 14. Rights and Remedies on Default.

Remedies. Upon the occurrence of any event of default and at any time thereafter. Trustee or Lander may exercise any one or more of the follow ing rights and remedies, in addition to any other rights or remedies provided by law:

Lender-shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.

With respect to all or any part of the Real Property, the Trustee shall have the

right to Toreclose by judicial foreclosure, in either case in accordance with and to the full extent provided by applicable law. With respect to all or any part of the Personal Property. Lender shall have all the rights and remedies of a secured party under the Uniform Commercial Code in effect in the state in which the Lender is located.

Lender shall have the right, without notice to Grantor, to take possession of the Property and collect the Income, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedness and unbernace of this right. Lender may require any tenant or other user to make payments of rent or use fees directly to Lender. If the Income is collected by Lender, then Grantor irrevocably designates Lender as Grantor's attorney in fact to endorse instruments received in payment thereof the mame of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligation for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Lender shall have the right to have a receiver appointed to take possession of any or all of the Property, with the power to protect and preserve the Property to ope ate the Property preceding foreclosure or sale, and to collect the Income from the Property and apply the proceeds, over and above cost of the receivership, against the Indebtedness. The receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property-exceeds the Indebtedness by a substantial amount

Employment by Lender shall not disqualify a person from serving as a receiver.

If Grantor remains in possession of the Property after the Property is sold as provided above or Lender otherwise becomes entitled to possession of the Property upon default of Grantor Shall become a tenant at will of Lender or the purchaser of the Property and shall pay while in possession a reasonable rental focuse of the Property.

If the Real Property's submitted to unit ownership. Lender or its designee may vote on any matter that may come before the members of the association of unit-owners, pursuant to the power of attorney granted Lender in Section 16.2.

Trustee and Lender shall have any other right or remedy provided in this Deed of Trust, or the Note.

14.2 Sale of the Property. In exercising its rights and remedies, the Trustee or Lender shall be free to sell all or any part of the Property together or

separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

14.3 Notice of Sale Lender shall give Grantor reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least ten

days before the time of the sale or disposition.

Waiver, Election of Remedies. A waiver by any party of a breach of a provision of this Deed of Trust shall not constitute a waiver of or prejudice the party srights otherwise to demand strict compliance with that provision or any other provision. Election by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an obligation of Grantor under this Deed of Trust after failure of Grantor to perform shall not affect Lender's right to declare a default and exercise its remedies under this Deed of Trust.

14.5 Attorneys Fees: Expenses. If Lender institutes any suit or action to enforce any of the sterms of this Deed of Trust, Lender shall be entitled to

recover such sum as the court may adjudge reasonable as attorneys' fees at trial and on any appeal. Whether or not any court action is involved, all reasonable expenses incurred by Lender that in Lender's opinion are necessary at any time for the protection of its interest of the enforcement of its rights shall become a part of the Indebtedness payable on demand and shall bear interest from the date of expenditure until repaid at the rate of 12 percent per annum for at the rate of the Note, whichever is higher. Expenses covered by this paragraph include (without limitation) all attorney fees incurred by Lender whether or not there is a lawsuit, the cost of searching records, obtaining title reports (including foreclosure reports), surveyors reports, appraisal fees, title insurance, and fees for the Trustee, to the extent permitted by applicable law.

# 15. Notice.

Any notice under this Deed of I rust shall be in writing and shall be effective when actually delivered or, if mailed, shall be deemed effective on the second day after being deposited as recistered or certified mail, postage prepaid, directed to the address stated in this Deed of Trust. Any party may change its address for notices by written notice to the other parties. Lender requests that copies of notices of foreclosure from the holder of any lien which has priority over this Deed of Trust be sent to Lender's address, as set forth on page one of this Deed of Trust. If the property is in California, the notice shall be as provided by Section 2924b of the C vil Code of California. 9 . 4 3

# Miscellaneous.

16.1 Successors and Assigns. Subject to the limitations stated in this Deed of Trust on transfer of Granton's interest, and subject to the provisions of applicable law with respect to successor trustees, this Deed of Trust shall be binding upon and inure to the benefit of the parties, their successors and

16.2 Unit Ownership Power of Attorney. If the Real Property is submitted to unit ownership. Grantor grants an irrevocable power of attorney to

Lender to vote in its discretion on any matter that may come before the members of the association of unit owners. Lender shall have the right to exercise this power of attorney only after default by Grantor and may decline to exercise this power, as Lender may see fit.

Annual Reports. If the Property is used for purposes other than Grantor's residence, within 60 days following the close of each fiscal year of Grantor shall furnish to Lender a statement of net cash profit received from the Property during Grantor's previous fiscal year in such detail as Lender shall require. "Net cash profit shall mean all cash receipts from the Property less all cash expenditures made in connection with the operaof the Property

16.4 Applicable Law. This Deed of Trust has been delivered to Lender in the state in which the Lender is located. The law of that state shall be applicable for the purpose of construing and determining the validity of this Deed of Trust and, to the fullest extent permitted by the law of any state in which any of the Property is located, determining the rights and remedies of Lender on default.

Joint and Several Liability. If Grantor consists of more thankone person or entity, the obligations imposed upon Grantor under this Deed of Trust shall be joint and several.
