

LAST WILL AND TESTAMENT  
OF  
BRUCE ROBERT WAYENBERG, SR.

I, BRUCE ROBERT WAYENBERG, SR., of Newberg, Yamhill County, Oregon, being of legal age, do hereby make, publish and declare this to be my LAST WILL AND TESTAMENT, as follows:

ARTICLE I.

I hereby revoke all Wills and Codicils previously made by me.

ARTICLE II.

I declare that PEARLE ELIZABETH WAYENBERG is my wife and is so referred to herein; that I have three children now living, namely: CHERYL ANN PICG, born June 20, 1949; BERNADETTE MARIE GOOLSBY, born November 28, 1941; and BRUCE ROBERT WAYENBERG, JR., born March 24, 1943, and no deceased children with lineal descendants. Except as provided below, I make no provision in this Will for any of my children who survive me, whether named herein or hereafter born or adopted, nor for the descendants of any child who does not survive me.

ARTICLE III.

I give, devise and bequeath to my wife, PEARLE ELIZABETH WAYENBERG, provided she survives me by thirty (30) days, all of my property, both real and personal and wherever situated.

ARTICLE IV.

If my wife, PEARLE ELIZABETH WAYENBERG, does not survive me by thirty (30) days, I give, devise and bequeath unto my children, in equal shares, to them or to the survivor or survivors of them, all of my property, both real and personal, provided, however, that in the event any of my children should predecease me leaving lineal descendants surviving them, then

their share is to be received by the lineal descendents of said child by right of representation.

#### ARTICLE V.

I hereby nominate and appoint my issue, BRUCE ROBERT WAYENBERG, JR., as and to be my sole Executor, to act without bond or letters testamentary, and I direct that after the probate of this Will, the filing of an inventory of my estate, publication of a notice to creditors, the entry of a decree of solvency, or the compliance with any other preliminary steps which may be necessary under the laws of the State of Oregon, my said estate be settled and distributed without the intervention, supervision or control of the probate or any other court, said nonintervention powers shall be unrestricted, and I specifically direct that my said Executor shall have full authority and act with full power to sell, convey and/or mortgage any and all of my real estate or personal property, whether the same is necessary for the payment of estate expenses or not, without an order of any court and at such price and upon such terms as in his discretion he deems best.

#### ARTICLE VI.

In the event my issue, BRUCE ROBERT WAYENBERG, JR., cannot or will not act as executor of my estate, then in that event I nominate and appoint my issue's husband, DOYLE W. GOOLSBY, as and to be my Executor to act without bond and without the intervention of the Court and with the same powers heretofore granted my Executor in Article V.

IN WITNESS WHEREOF, I have hereunto set my hand and published and declared this my LAST WILL AND TESTAMENT, on this 11 day of April, 1984.

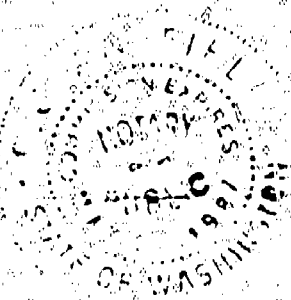
