CORRECTION DEED

THE GRANTORS, R. M. HEGEWALD and HELEN HEGEWALD, husband and wife, and CARSON HOT MINERAL SPRINGS, INC., a Washington Corporation, do hereby give, convey, and quit-claim to the SKAMANIA COUNTY CEMETERY DISTRICT, as a gift, the following described real estate, situated in the County of Skamania, State of Washington, including any interest therein which grantors may hereafter acquire:

A tract of land situated in the southwest one quarter of the southeast one quarter of Section 21, Township 3 North, Range 8 East, W.M., specifically known as the St. Martin's Cemetery and more particularly described as follows:

Commencing at the brass monument marking the south one quarter corner of the said Section 21; thence running N 89° 57' 20" E, along the south line of said Section 21, 1132.27 feet; thence running N 00° 02' 40" W, 239.7 feet to a point approximately 0.5 foot outside the existing cemetery, and the point of beginning of said tract; thence running N 04° 30' W along a line approximately 0.5 foot westerly of said cemetery, 86.0 feet; thence running N 85° 30' E along a line approximately 0.5 foot northerly of said cemetery, 86.0 feet; thence running S 04° 30' E along a line approximately 0.5 foot easterly of said cemetery, 86.0 feet; thence running S 85° 30' W, along a line approximately 0.5 foot southerly of said cemetery 86.0 feet to the point of beginning. This tract of land contains 0.17 of an acre more or less.

TOGETHER with a non-exclusive easement over and across the existing roadway accessing from St. Martin Springs Road #20580 into the aforescribed property and the right to maintain the same.

THIS DEED IS GIVEN TO CORRECT the description used in a previous deed between the parties hereto, dated July 19, 1984, and recorded July 23, 1984, in Vol. 83 of Deeds, page 727, under Auditor's File NO. 97929, records of Skamania County, Washington.

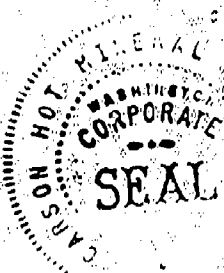
