That I am the lawful surviving spouse of LOWELL B. KLEVELAND, who died on the 29th day of May, 1984, in Camas, Clark County, washington, having provided for the disposition of all community property owned by said decedent and your affiant under a Community Property Agreement dated July 7, 1971, recorded on the 7th day of July, 1971, under Auditor's File No. 73645, in Book 63, at Page 39, records of Skamania County, Washington.

It is intended that the statements set forth herein shall be considered representations of fact which may be relied upon by all persons dealing with any and all real and personal property owned by the decedent and his surviving spouse at the time of death.

FIRST: That the parties to the aforementioned Community Property Agreement entered into no subsequent agreements which would have effect of abrogating or nullifying said agreement.

SECOND: That the decedent left no separate property.

THIRD: That affiant knows of her own knowledge and so states that all obligations against the marital community and against the estate of the decedent have been paid in full or otherwise provided for; that the value of decedent's share is less than the minimum value which requires the filing of a Federal Estate Tax Return under federal law applicable on date of death and that no taxes imposed by the Washington Estate and Transfer Tax Reform Act of 1981 are due.

COMPTON.
