- That the injury for which the estate claims damages against the County of Skamania, State of Washington, occurred on the 7th day of August, 1984.
- 2. That the place of injury was 10.32 miles Northeast of Washougal, Washington, in Skamania County, Bashington on State Route 140, approximately 0.11 miles Northeast of Mile Post 11.
- 3. That the location and description of the defect which caused the imjury are as follows:
 - Jack J. Peterson, address 0.03 Kelley-Henke Road, Stevenson, Washington, a Skamania County weed control employee, while driving an official vehicle of Skamania County, plate license #C 44141, in an easterly direction on State Route 140, drove across the center line of the highway and caused a head-on collision with a 1968 Jeep being driven by Mark T. John W. Stevenson Wilder in a westerly direction. was a passenger in the Jeep automobile.
- Multiple traumatic That the injury is described as follows: injuries resulting in his death.
