CLAIM FOR DAMAGES

To the Board of County Commissioners of Skamania County, Washington.

PLEASE TAKE NOTICE that in accordance with Chapter 36.45 of the Revised Code of Washington, I, Mark T. Wilder, hereby present you with a claim for damages against the County of Skamania, State of Washington, with the information required to be given by RCW 36.45.020 as follows:

1. That the injury for which I claim damages against the County of Skamania, State of Washington, occurred on the 7th day of August, 1984.

2. That the place of injury was 10.32 miles Northeast of Washougal, Washington in Skamania County, Washington on State Route 140, approximately 0.11 miles Northeast of Mile Post 11.

3. That the location and description of the defect which caused the injury are as follows:

Jack J. Peterson, address 0.03 Kelley-Henke Road, Stevenson, Washington, a Skamania County weed control employee, while driving an official vehicle of Skamania County, plate license #C 44141, in an easterly direction on State Route 140, drove across the center line of the highway and caused a head-on collision with a 1968 Jeep being driven by Mark T. Wilder in a westerly direction.

4. That the injury is described as follows: Fracture of the pelvis at the hip joint with probable permanent injury due to arthritis, fracture of the femur, nasal fractures with orbital rim and floor fractures, lacerations and contusions.

5. That the amount of damages claimed is as follows: EIGHT HUNDRED THOUSAND DOLLARS (\$800,000.00).

6. That the actual residence of the claimant at the time of presenting and filing this claim is:
