RATIFICATION AND RENTAL DIVISION ORDER

KNOW ALL MEN BY THESE PRESENTS:

That, WHEREAS, that certain oil and gas lease, dated October 5, 1981, from S.D.S. Co., a partnership, Bingen, Washington, as Lessors, to BWAB Incorporated, Denver, Colorado, as Lessee, recorded in Book 211, Page 409 of the Oil & Gas Records of Klickitat County, Washington, is owned by BWAB Incorporated

in so far as it covers the following described land in Klickitat & Skamania County, Washington to-wit:

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations, we Bruce R. Stevenson, Wesley D. Stevenson, Mark E. Stevenson, John L. and Laura S. Cheney, Anne Stevenson, Douglas T. and Leslie S. Campbell

and each of us, do hereby ratify, approve, confirm, and adopt the above described oil and gas lease in so far as it covers the above described land, and do hereby lease, demise and let said land unto BWAB Incorporated subject to and under all of the terms and provisions of said lease, and as to said land, do hereby agree and declare that said lease is now in full force and effect, that payment has been duly made of the entire bonus consideration and all of the delay rentals necessary to extend said lease to the next rental paying date, and each of the undersigned agrees that any delay rentals which may be paid under the terms of said lease with respect to the above described land may be divided as follows:





MODIFICATION NO. 1 TO PARTNERSHIP AGREEMENT

S.D.S. CO.

AGREEMENT effective as of the first day of January, 1984, among BRUCE R. STEVENSON, MARK E. STEVENSON, ANNE STEVENSON, LAURA S. CHENEY, JOHN L. CHENEY, LESLIE S. CAMPBELL and DOUGLAS T. CAMPBELL ("the partners").

RECITALS:

1. By document effective October 1, 1978, ("the partnership agreement"), the partners, together with Wesley D. Stevenson, reduced to writing their agreement with respect to the continuance of a partnership doing business under the name of "S.D.S. Co."

2. The partners now desire that the partnership agreement be modified to reflect that Wesley D. Stevenson sold his entire interest in the partnership, in equal shares, to Bruce R. Stevenson and Mark E. Stevenson.

AGREEMENT:

1. Paragraph (a) of the partnership agreement shall be amended to read as follows:

"(a) Until change, the capital accounts of the partners shall be maintained in the following percentages:

2. The following changes shall be made to paragraph 6 of the partnership agreement:

(a) The second sentence of paragraph 6 shall be amended to read as follows:

"One representative shall be designated by Bruce R. Stevenson and Mark E. Stevenson and one representative shall be designated by Anne Stevenson, Laura S. Cheney, John L. Cheney, Leslie S. Campbell and Douglas T. Campbell."

(b) The first sentence of the fourth paragraph of paragraph 6 shall be amended to read as follows:

"Bruce R. Stevenson and Mark E. Stevenson hereby designate Bruce R. Stevenson, and, in his absence, Mark E. Stevenson, as their representative and Managing Partner."
