Legal Description

Parcel A: The Northeast quarter of the Northwest quarter; and the Northwest quarter of the Northeast quarter of Section 20, Township 2 North, Range 5 East of the Willamette Meridian, lying Northerly and Easterly of the centerline of the channel of the West Fork of the Washougal River;

and that portion of the Southwest quarter of the Northeast quarter of said Section 20 lying Easterly of the centerline of the channel of the West Fork of the Washougal River and lying Northerly of the North line of that tract of land conveyed to Gordon R. Breaky in Book 78 of Deeds at page 164. Records of Skamania County, Washington.

Parcel B: The Northwest quarter of the Northeast quarter of the Northeast quarter of Section 20, Township 2, Range 5 East of the Willamette Meridian, Skamania County, Washington.
