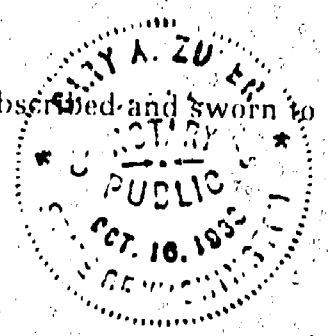

Provided however, that certain federal regulations may apply, in addition or in place of the above.

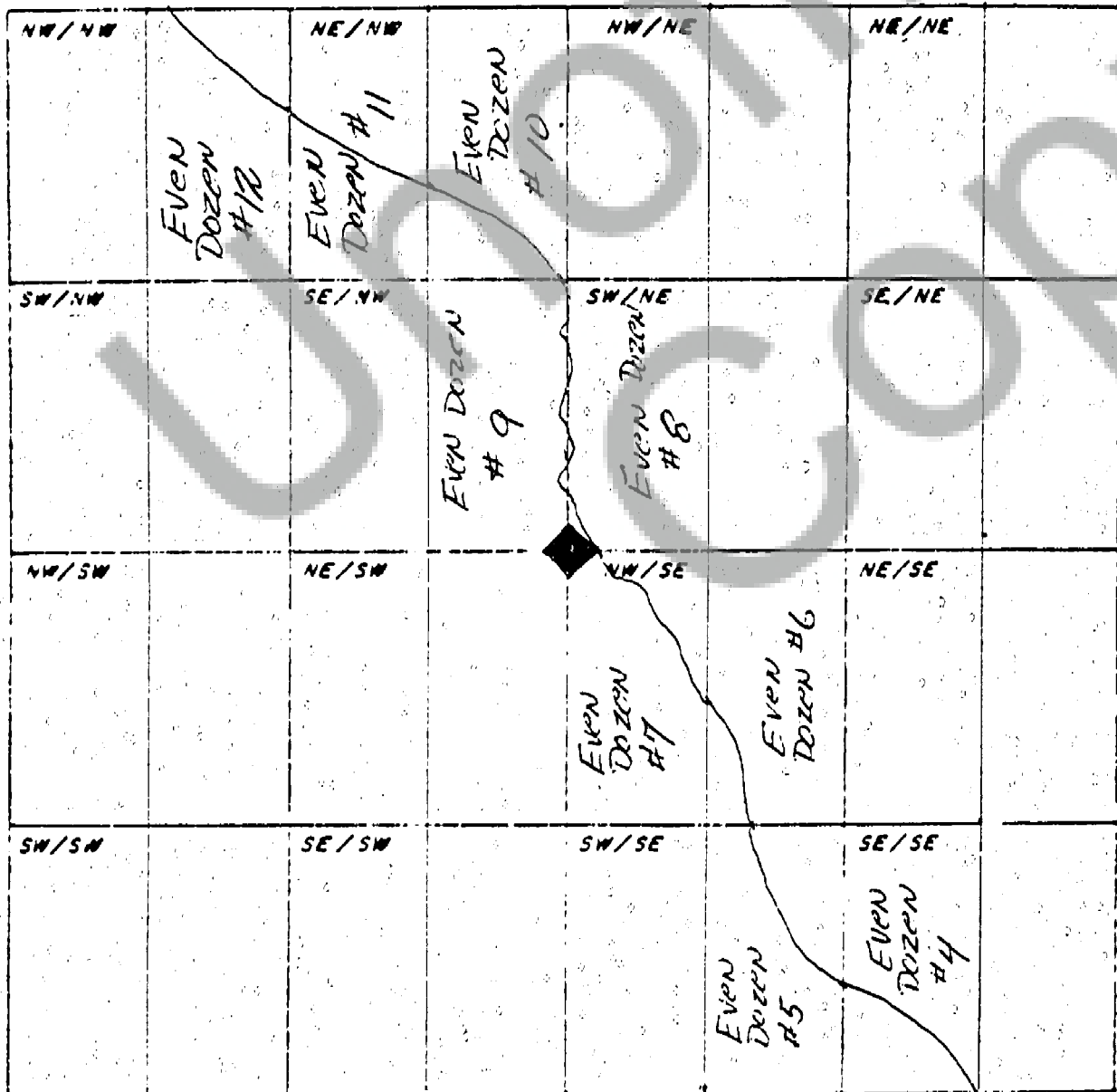
