## QUITCLAIM DEED

WHEREAS, the STATE OF WASHINGTON, DEPARTMENT OF NATURAL RESOURCES, by easement document dated September 28, 1977, filed for record under Auditor's No. 85031 in Volume 73, pages 587-591, in Skamania County Auditor's office, was granted an easement over and across a tract of land, as hereinafter more specifically described, for the purpose of constructing and maintaining a road to provide access for hauling forest products and other valuable materials and for land management and administrative activities, said easement having been granted by Longview Fibre Company, of Longview, Washington, and

WHEREAS, said easement was granted over and across the following described lands situated in Skamania County, Washington, to wit:

the NE1/4NW1/4, Section 23, Township 3 North, Range 8 East, W.M., and,

WHEREAS, the Washington State Department of Natural Resources no longer has any need for such easement rights, as was granted by said easement,

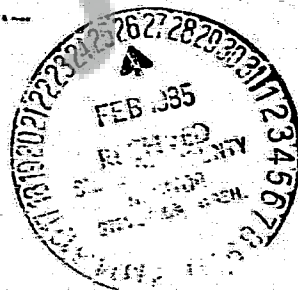
