QUITCLAIM DEED

WHEREAS, the STATE OF WASHINGTON, DEPARTMENT OF NATURAL RESOURCES, by easement document dated June 26, 1961, filed for record under Auditor's No. 58659 in Volume 49, pages 60-62, in Skamania County Auditor's office, was granted an easement over and across a tract of land, as hereinafter more specifically described, for the purpose of constructing and maintaining a road to provide access for forest protection, reforestation, development and utilization, including logging purposes only, said easement having been granted by Vera M. Borin and Ada V. Petersen, of 6815 Middle Way, Vancouver, Washington, and

WHEREAS, said easement was granted over and across the following described lands situated in Skamania County, Washington, to wit:

W1/2SW1/4, Section 3
N1/2SW1/4, N1/2, Section 10
Township 2 North, Range 5 East, W.M. and,

WHEREAS, said easement was for forest protection, reforestation, development and utilization including logging, and the Washington State Department of Natural Resources no longer has any need for such easement rights, as was granted by said easement,

NOW THEREFORE, the Washington State Department of Natural Resources does hereby convey and quitclaim all its right, title, and interest in and to the aforesaid easement, to Longview Fibre Company, of Longview, Washington.

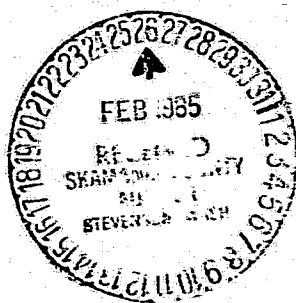
