QUIT CLAIM DEED IN LIEU OF FORFEITURE OF

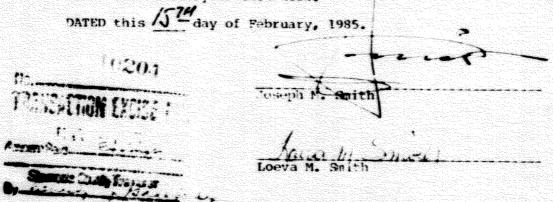
REAL ESTATE CONTRACT
