in hand paid, conveys and warrants to PAUL A. SEARS and CAROL D. SEARS, husband and wife

the following described real estate, situated in the County of Skamania , State of Washington: Lot 19, WHISPERING HILLS RIVER ESTATES, according to the official plat thereof, on file and of record at page 130 of Book "A" of Plats, records of Skamania County, Washington.

SUBJECT TO: A Deed of Trust, including terms and provisions thereof, on said property in the original face amount of \$64,500.00 executed by the grantor therein on August 14, 1980, in favor of Western Pacific Financial Corporation, a Delaware Corp. as security for a loan quaranteed (or insured) by the Administrator of Veterans Affairs under 38 U.
