

BEGINNING AT THE SOUTHEAST CORNER OF THE ABOVE DESCRIBED TRACT; THENCE WEST ALONG THE SOUTH LINE OF SAID TRACT, A DISTANCE OF 5 FEET; THENCE NORTH PARALLEL WITH THE EAST LINE OF SAID TRACT TO WHERE SAID LINE INTERSECTS THE SOUTHERLY RIGHT OF WAY LINE OF BAKER ROAD; THENCE SOUTHEASTERLY ALONG SAID RIGHT OF WAY LINE TO THE EAST LINE OF SAID TRACT; THENCE SOUTH ALONG SAID EAST LINE TO THE POINT OF BEGINNING OF THIS EXCEPTION.
