

Statutory Warranty Deed

THE GRANTOR

HAROLD B. CONNETT, a single man,

in hand paid, conveys and warrants to DAN ROSE and CONNIE L. ROSE, husband and wife,

the following described real estate, situated in the County of Skamania, State of Washington:

A tract of land located in the Northeast Quarter (NE₄) of Section 28, Township 2 North, Range 5 E. W. M., described as follows:

Beginning at a point on the southerly side of the right of way of the LaBarre County Road which point is south 1,572.20 feet and west 1,925.39 feet from the northeast corner of said Section 28; thence south 41° 38' 34" east for 572.46 feet; thence south 44° 32' 11" west 437.82 feet; thence north 41° 12' 56" west 500 feet to the southerly boundary of county road right of way; thence along boundary of right of way along curve to right with radius of 351.97 feet through a central angle of 09° 45' 00" a distance of 59.90 feet; thence north 45° 18' 00" east 169.73 feet; thence along curve to left with a radius of 290.44 feet through a central angle of 28° 35' 00" a distance of 144.89 feet; thence north 16° 43' 00" east 79.24 feet to the point of beginning; said tract containing 5.1301 acres, more or less.
