Assignor does further assign to Assignee all right, title, and interest in that certain Proof of Claim executed on behalf of Assignor herein on February 17, 1982 and filed under Bankruptcy Case No. 810975 in the Chapter 13 proceedings filed by Larry S. Ward and Frances M. Ward, husband and wife, in the United States Bankruptcy Court for the Western District of Washington.

The Assignor does hereby irrevocably appoint the Assignee and its assigns as true and lawful attorney in fact, with power of substitution and revocation, to demand and receive the above money, take out executions, and take in the name of the Assignor in all lawful ways, and means for the recovery of the money due or to become due, and on payment, to acknowledge
