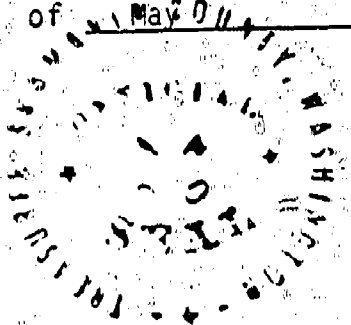

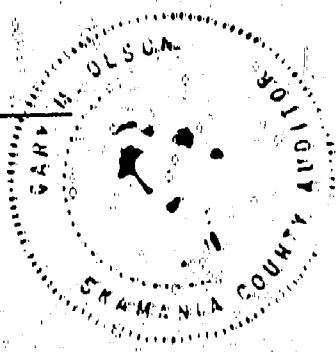

WHEREAS, the Board of County Commissioners of Skamania County, Washington, has determined that the following items of personal property, to-wit:

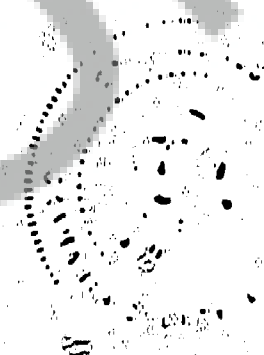
- (1) Those items listed on Schedule "A" which is attached hereto and hereby incorporated by reference; and

PASSED IN REGULAR SESSION this 22nd day of April, 1985.

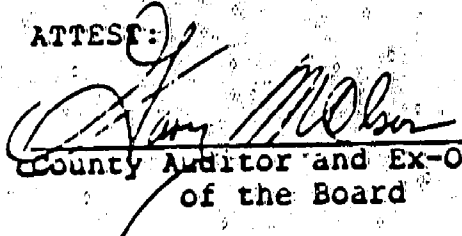
