EASEMENT AMENDMENT

THIS EASEMENT AND AMENDMENT is made and entered into this // day of , 19 % , by and between the STATE OF WASHINGTON acting by and through the Department of Natural Resources, herein called the "State," S.D.S.COMPANY, of Bingen, Washington and LONGVIEW FIBRE COMPANY, a Delaware corporation, herein called "S.D.S." and "Longview," with reference to the following facts:

- A. On the 7th day of November, 1984, S.D.S., Longview and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington, on the 26th day of November, 1984, in Volume 84 of Deeds, pages 98-127 under Auditor's File No. 98520, and in the records of Klickitat County, Washington, on the 10th day of December, 1984, in Volume 229 of Deeds, pages 67-96 under Auditor's File No. 196474, and in the records of Clark County, Washington, on the 27th day of December, 1984, on pages 163-192 under Auditor's File No. 3412270113.
- B. The State, S.D.S., and Longview desire hereby to amend the Easement so as to delete certain roads therefrom and to revise certain exhibits to more accurately show the road locations and correct errors therein.

NOW THEREFORE, the State, S.D.S., and Longview mutually agree as follows:

- There is hereby deleted from the Easement above described that certain road as shown in lavendar on the attached Exhibit A, over and across the NW1/4NW1/4, Section 3, Township 2 North, Range 7 East, W.M., in Skamania County, Washington. The legal description on Exhibit B-4 of the Original Easement is hereby revised to reflect this deletion.
- 2. There is hereby deleted from the Easement above described that certain road as shown in layendar on the attached Exhibit B over and across the N½NW¼4, Section 9, Township 6 North, Range 10 East, W.M., in Klickitat County, Washington.
- 3. There is hereby deleted from the Easement above described that certain road as shown in lavendar on the attached Exhibit C, over and across a portion of the SE1/4SW1/4. Section 11, Township 4 North, Range 10 East, W.M., as in Klickitat County, Washington.
- 4. Exhibit A-17 of the Original Easement is hereby revised to show more accurately the road location in the SE1/4NE1/4, and W1/2SE1/4. Section 35, Township 5 North, Range 11 East, W.M. The revised location is shown in green and the original location herein deleted is shown in brown on the attached Exhibit D.
- 5. Exhibit A-3 of the Original Easement is hereby revised to show more accurately the road location in the N½NE¼ and NE¼ANW¼, Section 9, Township 2 North, Range 7 East, W.M. The revised location is shown in orange and the original location herein deleted is shown in brown on the attached Exhibit A.
- 6. Except as herein expressly amended, the Original Easement is hereby confirmed and ratified and remains in full force and effect.
