1. History of Corner Establishment and Subsequent Restoration:

Corner originally set by Forest Service Surveyor Frederick W. Rase in May 1916.
 Set conglomerate stone 24"x12"x8" in ground over a stone marked with a cross-
 marked CC on Northwest face and 1 HES234 on side facing claim and marked:
 A Fir 8" N20-30W-46 lks. marked X1HES234BT
 A Fir 24" N68-18E-73 lks. marked X1HES234BT
 Raised mound of stone 3 ft. base 2 ft. high 3 ft. distance on last course of
 this survey Northwest of corner.

2. Description of Evidence Found:

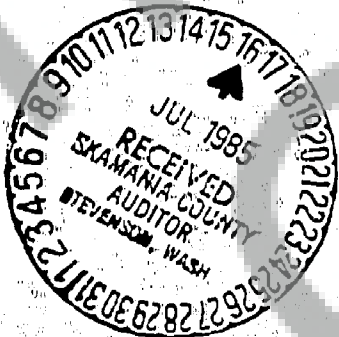
Stone 14x12x7 lying loose on top of a mound of stone X on top and marked HES 234
 on side facing claim and CC on Northwest.
 Orig. 8" Fir now 30" Wh. Fir N27W-30.4 ft. healed blaze (record N20W).
 Orig. 24" now 44" D-Fir N66E-48.2 ft. (slope distance) nearly healed blaze (record
 N68-18E).
 Unrecorded now 30" D-Fir S70W-5.6 ft. healed blaze.

3. Describe Monument, Accessories and Corollary Data to Perpetuate this Corner Location. Diagram corner and indicate meridian and reference to map of record. Surveyor's Field Book No. 1 Page No. 2 Date of work June 1985

Set 2 1/2"x30" Aluminum pipe with a 2 1/2" Aluminum cap. Marked:
 Buried orig. stone in hole next to monument.

Set guard post N29W with decals 54-2 and survey marker.
 Nailed 54-4 and BT signs to BT's and painted band and
 blazes red.
