## 1. History of Corner Establishment and Subsequent Restoration:

Corner originally set by Forest Service Surveyor Frederick W. Rase in May 1916.  
 Set granite stone 24"x6"x6" 14" in ground over a stone marked with a cross  
 marked CC on Northwest face and 2HES234 on side facing the claim and marked:  
 A Fir 30" N9-45E-45 lks. marked 2HES234BT  
 A Fir 36" N50-15E-37 lks. marked 2HES234BT

## 2. Description of Evidence Found:

Found orig. BT which by record stood N9-45E-45 lks. - now a sawed 36" Wh. Fir stump  
 which is either out of position or miss called by Rase - not used. From corner  
 set bears N7E-36.3 ft..

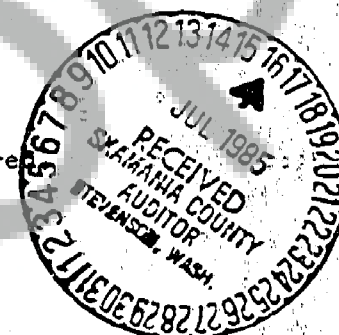

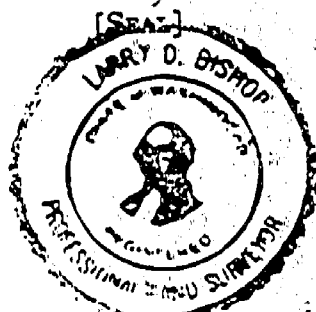
